

Post-Infection Illness Expert List

The RECOVER Initiative is a comprehensive research effort to understand, diagnose, prevent, and treat Post-Acute Sequelae of SARS-CoV-2 infection (PASC), including Long COVID. RECOVER researchers and collaborators recognized early on that this research could benefit not only people with Long COVID, but also shed light on other post-acute infection syndromes such as myalgic encephalomyelitis/chronic fatigue syndrome (ME/CFS), dysautonomia, and others.

RECOVER studies allow the scientific community to gain a deeper understanding of the biological mechanisms that may cause long-term effects of SARS-CoV-2 infection and the ways the virus affects the bodily organs and systems.

Investigators and clinicians with research expertise and clinical experience with post-infection syndromes, ME/CFS, and other illnesses are contributing within the RECOVER Initiative and participating in the Initiative's oversight committees and working groups.

Below is a current list of post-infection illness experts¹. This list represents only individuals who have confirmed their area(s) of expertise. We will update this list regularly with new information as additional experts participate in RECOVER's observational cohort, electronic health record (EHR), autopsy/tissue pathology, pathobiology, and clinical trial studies.
